Board Meeting Agenda Monday, January 13, 2025

The West Carroll Parish School Board will meet on Monday, January 13, 2025, at 6:30 p.m. in the auditorium of the West Carroll Parish Schools Media Center, located at 410 Willis Street, in Oak Grove, Louisiana. The agenda follows:

1. To approve the agenda,
2. To nominate and elect the 2025 President and Vice President of the West Carroll Parish School Board,
3. To receive an audit presentation from Kristina Sage of Kolder, Slaven, and Company, LLC for the fiscal year ending on June 30, 2024,
4. To recognize Mr. James “Jay” Morgan as West Carroll Parish Schools’ Bus Driver of the Year for the 2024-2025 school year,
5. To receive administrative updates from Oak Grove High School,
6. To approve the minutes of the December 9, 2024, Regular Board Meeting,
7. To receive the November 2024 financial report, including budget-to-actual comparisons,
8. To nominate and elect the 2025 Finance Committee of the West Carroll Parish School Board,
9. To set the day, time, and location of the Regular Monthly Board Meetings of the West Carroll Parish School Board as the first Monday of each month at 6:30 p.m. in the auditorium of the West Carroll Parish School Board Media Center, 410 Willis Street, Oak Grove, LA. The September Regular School Board meeting will be scheduled for September 8th in recognition of Labor Day,
10. To approve the proposed policies based on 2024 legislative updates and the review of Board counsel:
 - a. Policy CBD: Employment of the Superintendent—Includes provisions for evaluation, administrative leave, and the appointment of an interim superintendent,
 - b. Policy GAEEA: Title VII Employee Sexual Harassment—Includes mandatory reporting guidelines,
 - c. Policy GAK: Personnel Records—Restricts the release of WCPSB employees’ personal contact information,

- d. Policy GAMK (New Policy): Use of Pronouns and Given Names—Protects employees and students who call others by their given name and pronouns aligned to the gender assigned to them at birth,
 - e. Policy GBC: Recruitment—Includes provisions for employment of new employees,
 - f. Policy IDBA: Sex Education—Restricts discussions or instruction related to sexual orientation and gender identity,
 - g. Policy IDDF: Education of Students with Exceptionalities—Includes requirements for notification of the transfer of rights at the age of majority,
 - h. Policy JAAA: Title IX Sexual Harassment—Includes mandatory reporting guidelines,
 - i. Policy JGC: Student Health Services—Includes provisions for school nurse training and prescriptions for noncomplex health procedures.
11. To consider the option to list the Kilbourne High School sign for surplus sale,
 12. To approve a resolution adopting the Louisiana Attorney General’s guidance regarding H.B. 71 and the posting of the Ten Commandments,
 13. To celebrate School Board Recognition Month by showing appreciation to each Board member for their dedicated leadership and service to the students, schools, and communities of West Carroll Parish,
 14. To receive the monthly maintenance report and an update on projects, and
 15. To receive the monthly personnel report.
